Advance the practice of community policing as an effective strategy in communities' efforts to improve public safety.

COPS provides grants to tribal, state, and local law enforcement agencies to hire and train community policing professionals, acquire and deploy cutting-edge crime-fighting technologies, and develop and test innovative policing strategies. COPS-funded training helps advance community policing at all levels of law enforcement - from line officers to law enforcement executives - as well as others in the criminal justice field. Because community policing is by definition inclusive, COPS training also reaches state and local government leaders and the citizens they serve. This broad range of programs helps COPS offer agencies support in virtually every aspect of law enforcement, and it's making America safer, one neighborhood at a time.

COPS has invested \$11.3 billion to add community policing officers to the nation's streets and schools, enhance crime-fighting technology, support crime prevention initiatives, and provide training and technical assistance to advance community policing.

Mission:

*“The mission of the Drug Enforcement Administration (DEA) is to enforce the controlled substances laws and regulations of the United States and bring to the criminal and civil justice system of the United States, or any other competent jurisdiction, those organizations and principal members of organizations, involved in the growing, manufacture, or distribution of controlled substances appearing in or destined for illicit traffic in the United States; and to recommend and support non-enforcement programs aimed at reducing the availability of illicit controlled substances on the domestic and international markets.*

*In carrying out its mission as the agency responsible for enforcing the controlled substances laws and regulations of the United States, the DEA's primary responsibilities include:*

- *Investigation and preparation for the prosecution of major violators of controlled substance laws operating at interstate and international levels.*
- *Investigation and preparation for prosecution of criminals and drug gangs who perpetrate violence in our communities and terrorize citizens through fear and intimidation.*
- *Management of a national drug intelligence program in cooperation with federal, state, local, and foreign officials to collect, analyze, and disseminate strategic and operational drug intelligence information.*
- *Seizure and forfeiture of assets derived from, traceable to, or intended to be used for illicit drug trafficking.*

- *Enforcement of the provisions of the Controlled Substances Act as they pertain to the manufacture, distribution, and dispensing of legally produced controlled substances.*
- *Coordination and cooperation with federal, state and local law enforcement officials on mutual drug enforcement efforts and enhancement of such efforts through exploitation of potential interstate and international investigations beyond local or limited federal jurisdictions and resources.*
- *Coordination and cooperation with federal, state, and local agencies, and with foreign governments, in programs designed to reduce the availability of illicit abuse-type drugs on the United States market through nonenforcement methods such as crop eradication, crop substitution, and training of foreign officials.*
- *Responsibility, under the policy guidance of the Secretary of State and U.S. Ambassadors, for all programs associated with drug law enforcement counterparts in foreign countries.*
- *Liaison with the United Nations, Interpol, and other organizations on matters relating to international drug control programs.”*

*“Never has there been a greater need to increase our knowledge of drug abuse. Ever-changing drug use patterns, the continuing transmission of HIV infection among drug abusers, and the need to develop new and effective treatment and prevention interventions underscore the importance of research in finding new and better ways to alleviate the pain and devastation of addiction. Some of the Institute's goals in advancing this research are as follows:*

- *To design and develop new medications for opioid and cocaine addiction, especially for use during pregnancy, by building on the recent molecular discoveries that have uncovered the basis for addiction in the brain.*
- *To develop techniques to detect subtle effects of drug exposure in children of drug-using parents to provide opportunities for early preventive or clinical intervention.*
- *To broaden research on women and addiction to determine the biological and behavioral differences that need to be addressed in effective drug abuse prevention and treatment.*

- *To reduce the spread of HIV infection through improved drug abuse interventions and better understanding of the interactions of drugs of abuse and the body's immune system.*
- *To apply state-of-the-art neuroimaging techniques to the problems of drug abuse prevention and treatment.*
- *To design, develop, and test new behavioral therapies and promote their use for appropriate patient populations.*
- *To study the treatment of special clinical problems presented by drug abusers with HIV, TB, hepatitis, and other infections.*
- *To understand how organization, financing, and management affect the access to utilization, effectiveness, and cost of drug abuse prevention and treatment services.*
- *To identify the protective and resiliency factors that prevent drug use in those individuals with multiple risk factors, so more effective prevention techniques can be developed.*
- *To strengthen the research infrastructure, by providing additional opportunities for research training and career development for clinical researchers and improved mechanisms for training and mentoring of minority researchers.*
- *To expand the use of scientific information to educate the public about the real nature of drug abuse and addiction and the hope and promise for more effective prevention and treatment.*
- *To broaden the dissemination of research findings and improve drug abuse prevention and treatment practice and policy.”*

### Guiding Principles:

- *“NCIA espouses the following principles and conditions with regard to public policy on correctional industries at the federal, state, and local levels.*
- *The NCIA does not support elimination of mandatory preference laws. However, the NCIA would consider a phase out of mandatory preference laws provided that the phase out is conducted over several years under a pilot program structure that allows for: alternative market authorities to be granted to provide offender work, a subsequent impact review, and reinstatement and expansion if the pilot is unsuccessful.*
- *Compliance is recommended with standards, as applicable to correctional industry programs, including: United Nations standards, and International Labor Organization Conventions to which the United States is a signatory party, Federal standards, and American Correctional Association standards.*
- *Opportunities to increase inmate work through correctional industries should be open and available to all correctional industries at the Federal, state and local levels. The NCIA supports authority for Federal Prison Industries and state and local correctional industries to sell products and services to government agencies and not-for-profit organizations.*

- *All correctional industries should be authorized to participate in foreign labor substitute work programs outside of the authority of 18 USC § 1761(c) certification. The NCIA supports an amendment to 18 USC § 1761(b) to include foreign labor substitute work programs among the categories exempted from the prohibitions on interstate commerce of prison-made goods regulated by 18 USC § 1761(a).*
- *Federal law should allow all correctional industries at the Federal, state and local levels to participate in the Prison Industries Enhancement Certification Program according to the guidelines provided for under 18 USC § 1761(c).*
- *Correctional industries at the state and local level should have the right to self-determine the public policies affecting their organizational structure and parameters. Market and operational issues regarding services and value added should be dealt with at the state and local level and reflect the economic, political and social climate accordingly, and should not be mandated by federal government directive.”*

The centerpiece is simple--a red flag depicting blue, paper-doll-like figures of children holding hands. In the center, the white chalk outline of a missing child symbolizes the thousands of children lost to violence. Created by a 16-year-old student in Alameda County, California, and flown on the fourth Friday in April, the Children's Memorial Flag honors each lost child and raises public awareness about the continuing problem of violence against children.

The Children's Memorial Flag has also received support from mayors, directors of social service agencies and hospitals, schools, district attorneys, police chiefs, and others. Creating Parenting-Rich Communities is a multiyear project of CWLA, designed to develop resources, tools, and information parents and other leaders can use to assess their communities and bring about changes to improve the lives of children by supporting parents and caregivers.
